 - a. all relevant law, rules, regulations, restrictions, directions, and guidelines issued by the relevant authority; and
 - b. the Bank's regulations and practices, brought to my/our attention by display, advertisement or otherwise, as the foregoing are now in effect or as hereafter amended, enacted or adopted (collectively, the "Applicable Rules"). In the event of any inconsistency between the Applicable Rules and the Renminbi (CNY) Time Deposit Account Terms and Conditions, the Applicable Rules shall prevail.
