Customer agreement and declaration

We request the Bank to, in respect of the Cardholder(s) specified above, restrict their access as indicated above. In making this request, we understand and agree to the following:

- 1. While our request to block or have restrictions on certain Merchant Category Group or specified Merchant can be placed on the cards, these controls are not absolute and are subject to limitations.
- 2. Merchant Category Group codes and Merchant Category Codes are extensive and the codes are determined by each merchant together with MasterCard. The Bank is not responsible for how a business is categorized. It is therefore possible for transactions that are prohibited to be authorised where the merchant categorizes itself differently or inappropriately.
- 3. Occasionally, and on a limited basis (for example, where the issuer system is unavailable), authorizations are handled on the basis of the dollar amount of the transaction and not based on Merchant Category Group code, Merchant Category Code or Merchant name. These transactions may be authorized against your request in this form and the Bank is not responsible in such event.
- 4. We shall remain responsible for charges made on cards even if those purchases are made at a business for which we have requested the above restrictions to be placed.

We may, from to time, request the Bank to (a) impose similar restrictions to other Cardholder(s); or (2) amend the restrictions in respect of the Cardholder(s) specified above or other Cardholder(s). The above terms and conditions shall apply to all our requests made to the Bank from time to time.
